3.1 General membership programs

3.1.1 Types:

- a) Normal member: USD 1,100 (TWD 31,000)
- b) VIP member: USD 3,500 (TWD 100,000)

3.2.1 Type:

- a) Approved member: USD 0 (TWD 0)

3.2.2 Period: 1 year

4. Publication acquisition fee

The fee of acquiring AMRA publications through different programs is explained here.

Information included document file format, authorized user, due date, available edition and language.

4.1 Subscription

4.1.1 The program is only for all types of members. VIP members can subscribe for free.

4.1.2 The price is as [4.3 Summary of price cases](#), [disregarding the page count](#). Special cases will be proposed by the Secretariat and decided by the Board.

4.1.3 Document file format: PDF file

4.1.4 Authorized user: All employees in a member's company.

4.1.5 Due date: The same date as the membership due date of that term

4.1.6 Available edition: All editions during subscription period

4.1.7 Available language: All published languages

4.1.8 Special offer for contributors:

In order to create incentive to encourage members' participation in standard development, members can get discounts **(at most 60% off)** when subscribing AMRA standards because of following cases:

- a) **10% off** for TC members contributing the standard (contributors are listed in the "introduction" of a standard based on the consensus of TC)
- b) **20% off** for members with WG experts contributing the standard (contributors are listed in the "introduction" of a standard based on the consensus of the WG)
- c) **20% off** for members who volunteered for the WG chair.
- d) **10% off** for members who volunteered for the WG co-chair
- e) Applies to AMRA-220 and subsequent standards from 2022-03-04

4.1.9 Special offer for Approved members:

If a new Approved member is a pure AMR user (will NOT involve in manufacturing or selling AMR products), the management board can decide to offer the new Approved member free subscription of single or several specific standards during the review of its application.

- Not all Approved members can get free subscriptions.
- Free subscription is approved and granted individually for each standard.
- 1 year (Approved membership duration) only
